- vii. Audited Accounts for three (3) years (2016-2018)
- viii. Evidence of VAT Registration and Proof of past remittance.
- ix. The company is not bankrupt.
- x. Evidence of compliance with pension reform act, 2007
- xi. Tender document to be purchase by interested contractors/bidder upon payment non-refundable of tender fee.

- a. That all information presented in the pre-qualification bid are true and genuine. That the Director(s) has/have never been convicted for criminal offence relating to fraud or financial impropriety or criminal misrepresentation on falsification of facts.
