Executive Order No. 001 of 21st day of December, 2023

An Executive Order on the Promotion of transparency and efficiency in the business environment in Yobe State.

WHEREAS: *The Yobe State Government is to create an enabling environment for business and entrench measures and strategies aimed at promoting transparency and efficiency.*

NOW THEREFORE: *by the authority vested in me as Executive Governor of Yobe State by the constitution of the Federal Republic of Nigeria 1999 as amended and in order to create an enabling environment for business and entrench measures and strategies aimed at promoting, transparency and efficiency in the state, it is hereby ordered as follows:*

Section 1. Establishment. *The Yobe State **Promotion of transparency and efficiency in the business environment** is hereby established.*

Section 2.MDAs with the responsibility. *The underlisted MDAs of Yobe state shall publish on the state official website(s) all relevant information on fees, procedures, Service Level Agreement (SLA), Grievance Redress Mechanism (GRM) for all core business regulatory processes provided by the MDAs.*

Section 3.Function of the MDAs.

Executive Order No. 001 of 21st day of December, 2023

- a. *The MDAs shall publish on the state official website(s) advance communication rules of upcoming changes to the information on any of the items mentioned above such changes shall come into effect only after a minimum of thirty (30) days after the date of notice of the changes.*
- b. *The MDAs shall provide contact information (telephone and email) which must remain functional during working hours.*

Section 4. Applicability.

This order is applicable to:-

- a. *Ministry of Commerce Industry and Tourism;*
- b. *Ministry of Environment;*
- c. *Yobe Water Corporation;*
- d. *Ministry of Works;*
- e. *Yobe State Environmental Protection Agency;*
- f. *Yobe State Internal Revenue Service; and*
- g. *Yobe State Ministry of Housing and Urban Development.*
