OPENING REMARKS

Opening remarks was presented by Alhaji Kashim Tijjani Kalli, the Permanent Secretary, Ministry of Commerce, Industry and Tourism who also serve as chair. In his remarks, he highlighted that the primary goal of these committee is to promote the export of Agricultural commodities and other non-oil prospect from Yobe State.

He further explain that, despite the prevailing security challenges, the state government under the able leadership of His Excellency HON. Mai Mala Buni CON has taken proactive measure to create enabling business environment for exportable commodities. Notably, the establishment of sesame seeds plant in Machina LGA (already in operation), and ongoing similar project in Potiskum and Damaturu demonstrates the commitment of this objective.

2-The meeting went ahead for self-introduction of the committee members for proper familiarization.

3-The Committee set up a 9 members committee that will developed export drafting strategy and terms of reference that will guide the implementation of effective export initiatives across Yobe State.

The Permanent Secretary who serve as chair directed the Secretary of the committee to Co-opt the following in the committee due to their relevance.

4-The chairman asked the committee to think fast and identified way and means for executing its assignment. The meeting urge the committee to identified terms of reference first, through which a line of action can be drawn.

OTHER BUSINESS

The Managing Director Yobe Investment Limited rightly emphasizes the need for precise exportable statistics. He further explain that understanding the exact number and trends

will inform targeted efforts and resource allocation,he suggested to used Sesame seed plant as focal point for statistics in a practical approach.

The CG of Customs encourages leveraging Yobe's agricultural strength. Agriculture remains the cornerstone of the state's economy, and harnessing this potential is essential for sustainable growth.

The ES of Small Scale emphasized the importance of defining clear terms of reference at the outset. This will provide a roadmap for our efforts and ensure alignment.

The President of Yobe Shippers Council highlighted the needs for promoting awareness and sensitization campaign as a tool for yielding substantial returns over time.

The representative of Raw Material Research Center expresses readiness to collaborate with the committee to move the state forward whenever there is need for action.


